Commentary and analysis

Market overview

Global stocks rallied 6.3% in US dollars in Q2 (12.3% in rands) as technology companies regained their 2020/2021 glory days. The advent of ChatGPT and generative artificial intelligence (AI) has fascinated the market and the frenzy in AI stocks has been hard to ignore this year. Morgan Stanley notes that "the 39% rally in the Nasdaq 100 is its best 6 month start to a year ever". Apple became the first company to trade above a \$3trn market cap, nearly double the entire market cap of the German DAX. NVIDIA, a primary supplier of AI chips, has surged 189% YTD. On average the top 7 tech stocks have risen over 70% YTD while the remaining 493 stocks in the S&P 500 have essentially done nothing. The 'magnificent seven' s performance has lifted equities 15.7% in the past year (34.1% in rands).

In South Africa, the FTSE/JSE Capped SWIX Index brushed off stage 6 loadshedding, rallying 3.4% in April as investors believed global central banks would pivot on the wake of lower inflation prints. However, in May, news that SA might have supplied Russia with arms in December sent markets into a tailspin, selling off 5.8% before recovering 3.8% in June. For Q2, SA equities rallied 1.2% and are up 13.5% in the past year. Looking at the JSE sectors, industrials led the rally (+34.2%) as companies like Richemont benefitted from the China reopening trade. Financials, thanks to higher interest rates, were up 13.6%. Resources lagged the two sectors, only up 3.0% as metal prices remained low.

Portfolio review

The fund has outperformed its benchmark in Q2 reducing some of the underperformance it experienced in the past year. Looking at the longer periods, it has outperformed the market for 5 consecutive years.

As resource companies continued to sell off during the quarter – concerns of insufficient stimulus from China, profit taking and lower commodity prices - underweight positions in gold and platinum shares added significantly to alpha. In addition, the fund's overweight exposure to Chinese consumers through Richemont and Prosus benefitted from the China reopening trade. Looking at the managers, Coronation, M&G and Visio outperformed while Ninety One and Truffle struggled. Coronation's valuation driven philosophy picked up on cheap Chinese companies and when the shares struggled in 2022 (regulators were coming down on technology companies), the manager stuck with them reaping the benefits in the past year. M&G and Visio performed well for similar reasons to Coronation. On the managers that struggled, Truffle was underweight Naspers, a company that rallied 44% in the past year. Despite recent underperformance, the manager remains the biggest contributor to performance in the past 5 years.

Portfolio positioning and outlook

There was little change in the fund's biggest active bets in Q2, it remains overweights consumer discretionary and technology and underweight financials and real estate. In the first two sectors, the positions are dominated by Chinese linked Richemont and Prosus. In financials, the underweight is in life companies.

Managers are expecting inflation to continue decelerating in the second half of the year but have pushed out expectations of a US Fed pivot into the first quarter of 2024. Recessionary concerns have reduced given the strong labour market in the developed countries, but some managers are starting to point to cracks in the data, like the reduction in hours worked. In South Africa, the BRICs summit in August will be a defining event as developed countries are watching with an eagle eye whether Russia's president will attend and if he does, whether the country will honour its obligation from the Rome Statute of arresting him. Results of the Lady R investigation will be another defining moment for the country. The outcome of these events is important for domestically focused companies and sentiment towards the country and, if positive, is likely to have a positive effect on SA equities.

Information to be considered before investing

Unit price - how it works

Prices are calculated and published on each working day, these prices are available on the Manager's website (www.stanlib.com) and in South African printed news media. This portfolio is valued at 15h00. Forward pricing is used. Investments and repurchases will receive the price of the same day if received prior to 15h00.

The payment of withdrawals may be delayed in extraordinary circumstances, when the Manager with the consent of the Fund trustees deems this to be in the interest of all Fund investors. These circumstances may include periods when significant underlying markets suspend trading which will prevent accurate valuation of the instruments held in the Fund. When the suspension of trading relates to only certain assets held by the Fund, these assets may be side-pocketed. This process allows normal liquidity on the assets that can be valued but, will delay liquidity on the affected portion of the Fund. If the Fund is faced with excessive withdrawals, the affected withdrawals may be ring-fenced, which is the separation and delayed sale of the assets reflecting the interest of the liquidity seeking investors. It ensures that the sale of a large number of units will not force the Manager to sell the underlying investments in a manner that may have a negative impact on remaining investors of the Fund.

Performance information

All performance returns and ranking figures quoted are shown in ZAR and are based on data sourced from Morningstar or Statpro and are as at 30 June 2023. Annualised return figures are the compound annualised growth rate (CAGR) calculated from the cumulative return for the period being measured. These annualised returns provide an indication of the annual return achieved over the period had an investment been held for the entire period. Actual annual figures are available on request from the Manager. Portfolio performance figures are calculated for the relevant class of the portfolio, for a lump sum investment, on a NAV-NAV basis, with income reinvested on the ex-dividend date. Individual investor performance may differ due to initial fees, actual investment date, date of reinvestment of income and dividend withholding tax. Portfolio performance accounts for all costs that contribute to the calculation of the cost ratios quoted, all returns quoted are after these costs have been accounted for.

Total Expense Ratio (TER) and Transaction Costs (TC) = Total Investment Charge (TIC) and other fees

The TER is calculated as a percentage of the average net asset value of the portfolio incurred as charges, levies and fees in the management of the portfolio. The TER is a measure of the actual expenses incurred by the fund over a one and three-year period (annualised). This includes the TER charged by any underlying fund(s) held as part of this Fund. A high TER does not necessarily imply a poor return nor does a low TER imply a good return. The current TER should not be regarded as an indication of future TER's.

Transaction costs are disclosed separately. Transaction costs are a necessary cost in managing a fund and impacts the fund's return. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.

The sum of the TER and Transaction Costs is shown as the Total Investment Charge (TIC).

Annual management fee: The Fund charges a fixed annual management fee (i.e. fee class) as a percentage of the assets under management, to ensure a simple and understandable fee structure. The Fund invests primarily in segregated mandates but may also invest in other unit trusts i.e. "Underlying Fund Fees", which are included in the Total Expense Ratio (TER). The annual management fee is accrued daily and paid on a monthly basis.

Advice fees: If an investor appoints an adviser, advice fees are contracted directly between the investor and the adviser. The Manager will facilitate the collection of advice fees only upon receiving an investors instruction to do so. Initial advice fees up to a maximum of 3.45% are collected prior to units being purchased and ongoing advice fees up to a maximum of 1.15% are collected monthly through the redemption of units held by an investor in the Fund. An investor may cancel the instruction to facilitate the payment of advice fees at any time.
